## Conditions of Membership

### Social Membership

Second included 18 hole round	<ul style="list-style-type: none"> <li>• <i>Must provide current details required by club (email, phone, etc.) and allow marketing of club and partners</i></li> <li>• <i>New members only (2 year non-member) or coming from discounted offers (e.g. 2-4-1, short term)</i></li> <li>• <i>Not eligible to win major competitions</i></li> <li>• <i>Restricted tee time bookings to after 11.00 on comp days or vacant slots on walk up</i></li> <li>• <i>Must play minimum 5 x 18 hole competitions within 12 months (Admin fee \$50 if not completed)</i></li> <li>• <i>First 2 x 18 holes rounds included (provided first year only) to be played in comps or in obtaining handicap on comp days. ### Full

Any person who has paid the maximum authorised subscription and has been admitted to this category by the Board shall have all the privileges of membership including playing rights on any day unless there is a competition being run to which that person is ineligible

### Senior

Any Full Member who has been a continuing member of the Club for at least 10 years and who has attained the age of sixty five (65) years shall upon application to the Board to that end become liable to pay, from the date of application to the 1st of April following, Such senior Full Members retain all membership privileges.

### Special

A member who has been a continuing Full Member of the Club for 25 years or more shall upon application to the Board to that end become liable to pay, from the date of application to the 1st of April following, Such special Full members retain all membership privileges

### Restricted

Are persons who elect to pay a reduced subscription rate, (See by-law) and are entitled to playing rights on all days except Saturday and Sunday. Restricted members may use facilities provided by the club on Saturday and Sunday upon such terms as the Board from time to time may prescribe

### Junior Youth

A person, who has attained the age of 18 and not reached the age of 21, or; a person, who has reached the age of 21 but not reached the age of 25, and is a full time student, unless elected to another category.

A person, who has not reached the age of 25 and is not a full time student, may make application to the Board for admission as a Youth member if they show reasonable circumstances

### Junior Teen

A person, who has reached the age of 15 but not reached the age of 18

### Junior Cadet

Juniors 14 years or under

### Country 1 (A)

Any person eighteen (18) years or older who has a permanent place of abode and resides at that place situated not less than seventy-five ( 75) kilometre, or more than one hundred and fifty (150) kilometre radius from the club premises, by the shortest route may be admitted to this category

### Country 2 (B)

Any person eighteen (18) years or older who has a permanent place of abode and resides at that place situated more than one hundred and fifty (150) kilometre radius from the club premises, by the shortest route may be admitted to this category. (As the crow flies)
